WATER AND SEWER SERVICE LOCATIONS: No installation will take place prior to lot clearing. MCDPW will determine the best location for the water and sewer taps prior to house construction. A blue flag will be placed by the customer at the preferred tap location. If we are unable to accommodate that location, MCDPW will meet the applicant to determine best location. Water meters are installed at lot corners whenever practical. Sewer service connection locations vary due to topography, existing sewer main location and other requirements. Water meter boxes and sewer cleanouts are to be kept so that they are easily accessible for maintenance. There should never be landscaping concealing the location of the water meter box or sewer cleanout. Sewer cleanout must remain above grade. Payment for any damage done to the sewer cleanout, water meter, meter box or lid, etc. other than natural causes, will be the responsibility of the account holder(s). *Irrigation service requires the installation of an RPZ for backflow prevention. Signature of Account Holder indicates Account Holder's agreement to have the RPZ installed at the property owner's expense.
