We know how hard it is to be a good parent. Life gets complicated pretty quickly. We also know you want to do what's best for your children.

They need your financial support now more than ever. Children with two parents who are involved in their lives are less likely to:

- ✓ Be financially disadvantaged
- ✓ Drop out of school
- ✓ Use drugs
- ✓ Become teen parents

## CHILD SUPPORT BASICS

---

Child support is designed to meet the needs of children while being fair to both parents. The amount that you pay is based on each parent's income.

Child support helps pay for things that all kids need, such as food, clothing, housing, transportation, and school supplies. Your regular child support payments can make the difference between your child's financial security and living in poverty.

## HOW IT WORKS

---

At the Moore County Child Support Enforcement Agency, our responsibilities are to:

- ✓ Establish, monitor and enforce child support and medical support orders
- ✓ Collect and distribute support owed to children

We are committed to treating our customers, including mothers, fathers, and children, with respect and dignity.

We are committed to:

- ✓ Being fair and impartial
- ✓ Being sensitive to your needs
- ✓ Treating both parents with respect
- ✓ Keeping your information confidential
- ✓ Working with you when you have trouble paying your support

Your responsibilities are to:

- ✓ Pay your support in full and on time

- ✓ Keep us informed when things change such as your job, address, telephone number and/or income
- ✓ Provide health insurance if court ordered

## WHERE TO SEND YOUR PAYMENTS

Whether your payments are direct, from wage withholding, electronic funds transfer, etc., all child support payments must be sent to the North Carolina Centralized Collections Operations. Send your payment to:
