AFFIRMATION – Signature must be that of the owner, partner or principal officer or individual having power or attorney.

Any individual who willfully makes and subscribes an abstract (listing) required by this Subchapter (of the Revenue Laws) which he does not believe to be true and correct as to every material matter shall be guilty of a Class 2 misdemeanor. (Punishable by a fine not to exceed \$1,000 and/or imprisonment up to 60 days).

MILITARY PERSONNEL – All military personnel owning personal property must sign and return this abstract by January 31st. If your home of record is other than North Carolina and you are requesting property tax exclusion please send a current leave and earnings statement (LES) with the abstract. Military spouses may also be exempt from personal property taxes if their home or record is the same as the service member or if they reside in the home state of the service member. Two of the following documentation is required for spousal exemption: Spouse's current dependent and privilege card, current driver's license, voter id card and tax forms (all three must be same state of service members home of record).
