Health Director's Report

Russ Kelly, Environmental Health Technician, has been reclassified to an Environmental Health Associate. Moore County is the first county in North Carolina to include this position in its Environmental Health Department. As defined by the North Carolina Office of State Human Resources (NCOSHR), the minimum requirements for this position are as follows "Graduated with an associate, bachelor's, or postgraduate degree from a program that is accredited by the National Environmental Health Science and Protection Accreditation Council (EHAC) and satisfactorily completed general and specialized instruction and training in environmental health approved by the Department. Graduated with an associate, bachelor's, or postgraduate degree and earned minimum of 15 semester hours in the physical, biological, natural, life, or health sciences and satisfactorily completed general and specialized instruction and training in environmental health approved by the Department."

Environmental Health will host a Septic Systems conference on November 13th and 14th. This conference has been designed by Soil Scientist Nathan Hinson, who has been employed with Environmental Health since 2023.

Seasonal Respiratory Illness season peaks between the months of December and February. Recommendations are to receive both regular flu and covid19 vaccinations. The RSV virus impacts older adults, young children and those with medical conditions; RSV vaccinations are also highly encouraged.

According to the North Carolina K-12 Immunization Report for the 2023-2024 school year, Moore County Schools (MCS) displays better immunization non-compliance rates than overall state averages. State averages of immunization non-compliance versus MCS rates are as follows: State Kindergarten average of 4.68%, MCS Kindergarten average of 1.35%; State 7th grade average of 6.32%, MCS 7th grade average of 2.01%; State 12th grade average of 9.24% MCS 12th grade average of 0.75%.

Moore County Health Department received approval to remodel its Health Education wing which will be used as a collaboration and knowledge resource area. This remodel will allow for a more effective disease surveillance and response effort as well as improve workspace confidentiality for health education staff. The total cost of the remodel is approximately \$23,000.00 and is expected to have a three week start-to-finish time frame.

The department currently has vacancies for its Nutritionist II and Nutritionist III positions. A contract with Nutrition Plus to provide part-time nutrition services is in its final stages.

Oreya Bright and Nataya Redd have joined the Care Management program as Social Workers, while Jada Harris and Jean Boatman have joined the clinical team as the Maternal Health Program Nurse Coordinator and
