Board of Health Education/Staff Reports

State of the County Health Report (SOTCH)

The Moore County SOTCH Report was presented by Health Director, Matt Garner. The SOTCH Report is “a comprehensive analysis of the health status of a county in North Carolina, providing data on various health indicators and often used to identify community health needs and guide improvement strategies.” (North Carolina Department of Health and Human Services). *Presentation is attached in the Appendix as Document 1.*

Health Director’s Report

The renovation of the Health Education office will be complete by the end of December. This renovation consists of a 552 square foot area with two private offices and a common meeting area. The common area will house Epidemiology Team meetings. Federal Dollars were used to completely fund the renovation. The digital sign in front of the health department will be updated. The upgrade will feature modern technology and provide an improved display of department information, clinic offerings, closures, and advisories. This project has gone out for bid and received two offers. The lowest offer of \$38,551.00 was placed by a Moore County business.

Environmental Health Specialists, Connie Flowers and Eli Seawell received delegation of authority for public swimming pools. Delegation of authority occurs when the State Environmental Health Board issues an individual permission to inspect and permit facilities and systems. Environmental Health Specialist, Nicole Thomas, passed the Childhood Lead Poisoning competency requirements.

Foreign Language Interpreter Nilda Moran announced her retirement set for the end of the calendar year. Newest employees acquired by the health department are Environmental Health Specialist, Laura Jordan; Environmental Health Specialist Trainee, Jacob Odom; and Social Worker II, Aaliyah Smith. The department is currently advertising for WIC Nutritionists II and III, and Public Health Nurse III.
